An anonymous tip was received where contraband was to be transported to Churachandpur, thereby self along with a team consisting of SI Paul Lalhminglian of CCP-PS and team, Rfn. No. 1023512 Sanglun of 10th IRB attached with Cyber Cell, Churachandpur Police and 2(Two) women PC from WPS-CCP were deputed to conduct frisking and checking. In the meantime a requisition for deputing one Executive Magistrate was submitted to Deputy Commissioner, Churachandpur and Shri Lianminthang Samte MCS, SDC/EM, CCpur was deputed for Magisterial duty.

At around 4:20 pm while conducting frisking and checking at Central Lamka, CCPur, Behiang bus parking, while the passengers are de-boarding from one Tata Sumo, one unknown passenger was frisked where it was found to be one Mr. Hausuanlal Phiamphu 53 yrs s/o (L) Letkhankai Phiamphu of Tonzang village, Churachandpur, was in possession of 14 soap cases of suspected illegal drugs. Immediately, the 14 (fourteen) pieces (Soap case) of Illegal contraband suspected to be brown sugar is seized at 4:35PM and apprehend Mr. Hausuanlal Phiamphu 53 yrs s/o (L) Letkhankai Phiamphu along with one Mobile Realme C 63 5G bearing IMEI NO. 865737077516533/49 and 865737077516525/49 at the spot at 4:40PM in presence of Executive Magistrate. On brief interrogation of Mr. Hausuanlal Phiamphu 53 yrs s/o (L) Letkhankai Phiamphu of Tonzang village, Churachandpur, it was found that, the contraband was ordered by one Lalcha with mobile no 8415819351. Who was supposed to immediately take the contraband on reaching Lamka Town.

Thereafter, the joint team planned a controlled delivery of the goods to lure Mr.Lalcha, where the team positioned at the agreed delivery spot (i.e Vehicle parking at Central Lamka). On reaching the vehicle parking at Central Lamka, Mr. Lalcha came in a Honda Activa (Dark Grey in colour without registration number) to receive the contraband where He was caught red handed while making the transaction at around 4:50 PM. On proper verification he identified himself as Lamminlal Haokip (33) s/o Late Paolet Haokip of Thongkholui village near Khenjang Village, Churachandpur, and arrested him at 4:50 PM and seize one Mobile Realme 9I bearing IMEI NO: 860756056425073/24 and 860756056425065/24 and the aforementioned Honda Activa in presence of the Executive Magistrate at around 4:52 pm. Weighing of all the 14 (fourteen) soap cases was conducted in presence of Executive Magistrate and it was found to be 533 gms approximately including the weight of the soap case and 168 gms approximately without the weight of the Soap case. The seized items along with the arrested accused (suspected) persons is handed over to you for taking further necessary legal action as per law.
