Stops were placed and the Search party divided into two groups to thoroughly search the vegetated area. After extensive search of the area, at around 1315 hours on 28 Jul 2025 one of the party found a suspicious patch and on carrying detailed search, a hidden cache containing War Like Stores at GR 678926. The operation was continued to check for presence of similar caches in the suspected area. After thorough search of the area and no further recovery, the operation was terminated at 1500 hours on 28 Jul 2025.

 - a). 02 x AK 47(Burmese made).
 - b). 04 x Country Made Improvised Mortars (Pompi).
 - c). 02 x Single Bore Rifles.
