- 1. I have the honour to submit you the report that on 28 July 2025, based on input received from Chandel police and corroboration from own source regarding likely presence of War Like Stores in general area of Rd Bend (SQ 4211) astride Chakpikarong - Joupi road near Gamvet Mol (vill TM Dingpi) (Notified Area), a Joint Operation was launched by a column Comprising of strength of 01-01-40 ex COB Joupi and team of Chandel Police (06 persons) wef 0500 hours on 28 Jul 2025 to search the area. Stops were placed and the search party divided into three groups thoroughly searched the thickly vegetated area near the Indo Myanmar Border. After extensive search of the area, at around 1420 hours on 28 July 2025 one of the party found a suspicious patch and on carrying detailed search, a hidden cache containing War Like Stores was found at GR 425116. The operation was continued to check for presence of similar caches in the suspected area. After thorough search of the area and no further recovery, the operation was terminated at 1600 hours on 28 Jul 2025.
- 2. The following War Like Stores was recovered during the operations:
  - a). 02 x Lathodes.
  - b). 08 x Single Bore Rifles.
  - c).01 x Improvised Mortars.(Pompi)
  - d). 01 x Pump Action Shotgun.
- 3. Due to the shadow area in operation area the video coverage E-Sakshya could not be conducted.
