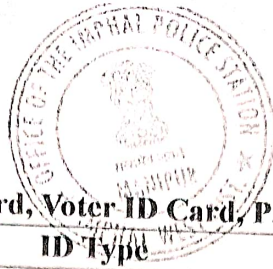

It is therefore, requested kindly to recover the stolen scooter and take up necessary legal action against the unknown miscreant(s) as per law.

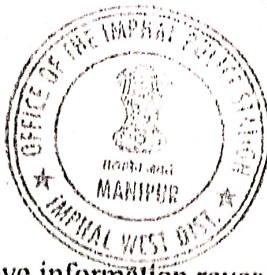
