Sub :- Report regarding fraudulent loan and misuse of personal documents.

Sir,

With due respect, I have the honour to report that in the month of March, 2022, I entrusted my family friend namely Ningombam Birjit Singh (51) S/o Ningombam Brojen Singh of Chingmeirong Maning Leikai, Tiscon Leirak, Imphal West District, Manipur, who assured me that he had reliable contacts and could arrange a two-wheeler loan for my son.

On 10<sup>th</sup> March, 2022, at around 01.30 pm, he came in front of my office, Narcotic Affairs of Border Police Station, Imphal West District, Manipur and took my signature on certain vehicle-related documents. Relying on his assurance, I also provided him with my bank account details to facilitate the loan for purchasing a Royal Enfield Meteor 350, Fireball Red in colour. After approximately two months, he delivered the said bike. However, I later discovered that the bike was not registered in my name but in the name of Sapam Jeet S/o Premjit Singh of Sega Road Konjeng Hajari Leirak, Imphal West District, Manipur.

Subsequently, I was shocked to learn that Ningombam Birjit Singh had fraudulently taken a car loan for a Honda Amaze, Red in colour bearing Regd. MN01AW-0039 using my account details without my knowledge or consent. The said car is currently in his possession. To this day, I have been made to repay the EMIs for both the motorcycle and the car loan, despite the fact that I am not the beneficiary of the car. Furthermore, he has recently blocked my number and has been untraced ever since, making it impossible for me to contact him.

So, I therefore request you to kindly to take necessary legal action against the said Ningombam Birjit Singh (51) for his fraudulent act and misuse of my financial information and to assist me in recovering my financial losses.
