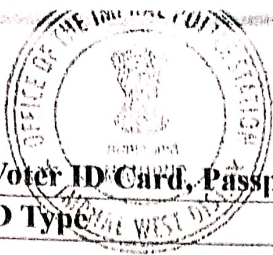

Subject: - Report.

Sir,

I have the honour to state that today i.e. 23/07/2025 at about 12:30 am, a reliable information was received from our own source and further corroborated from the information input provided by 2/8 GR (Indian Army) regarding the presence of some active cadres of KCP organization in and around North AOC and Khuyathong area with a view to commit prejudicial activities like extortion of money from educational institutions, government departments and general public etc. Based on the information, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri. P. Achouba Meitei, MPS, Dy.SP(CDO)IW and under the supervision of Shri. Gaurav Dogra, IPS, i/c Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at North AOC and Khuyathong area. During that one suspected person was detained near PCTC Oil Pump. On spot verification, the detainee identified himself as Konjengbam Kanta Meitei (23 yrs) S/o. K. Tomba Meitei of Takyel Khongbal Pungsumbam Leirak, Imphal West District.

During preliminary verification, he disclosed that he is an active member of KCP (Taibanganba) organization (a faction of KCP organization) and joined the said organization in January, 2025 through one Maibam John of KCP (Taibanganba) organization from Takyel area. He also disclosed that he is presently working under the command of one s/s Commander Moramba of KCP (Taibanganba) organization who is presently staying in Yaithibi Loukol. He further disclosed that under the instruction of the above mentioned Commander Moramba, he along with his associate namely one Tomba of KCP (Taibanganba) organization from Takyel area is involved in extortion activities by serving monetary demands/threats and collected money from educational institutions, government departments and general public located in valley area and the extorted money were handed over to their Commander Moramba as their party fund. Further, he disclosed that today i.e., 23/07/2025, under the instruction of Commander Moramba, he along with his above mentioned associate Tomba collected a sum of Rs. 22,000/- from educational institutions located in valley area.

Hence, he was arrested from the spot i.e., near PCTC Oil Pump at 01:48 pm by observing necessary formalities.

From his possession (i) one Redmi Note 10T 5G mobile handset along with one Airtel SIM card bearing mobile no. 7085797872 (as disclosed by him), (ii) one brown wallet containing a sum of Rs. 1100/- (Rupees one thousand and one hundred only) and one Aadhaar card bearing no. 4146 0078 7466 and (iii) a sum of extorted money i.e., Rs. 22,000/- (Rupees twenty two thousand only) were seized at the spot at 01:55 pm by observing due formalities.

As follow up action based on the disclosure made by the arrestee, the said CDO-IW team along with the arrestee rushed to Takyel area and as pointed out by the arrestee, his associate Tomba was successfully detained at Takyel Khongbal Khumanthem Leikai near a Bridge. On spot verification, the detainee identified himself as Sanatomba Aheibam (24 yrs) @ Sana @ Tomba S/o. Shyamkishwar Aheibam of Takyel Khongbal Maning Leikai, Imphal West District.

During preliminary verification, he disclosed that he is an active member of KCP (Taibanganba) organization (a faction of KCP organization) and started working for the said organization since January, 2025 and presently working under the command of the above mentioned s/s Commander Moramba @ Athouba (Ph. No. 9233685414 / 9233637464) of KCP (Taibanganba) organization. He also disclosed that under the instruction of the above mentioned Commander Moramba, he along with his associate namely one Konjengbam Kanta Meitei (the above mentioned arrestee) of KCP (Taibanganba) organization from Takyel area is involved in extortion activities by serving monetary demands/threats and collected money from educational institutions, government departments and general public located in valley area and the extorted money were handed over to their Commander Moramba as their party fund. Further, he also disclosed that today i.e., 23/07/2025, under the instruction of Commander Moramba, he along with his above mentioned associate Konjengbam Kanta Meitei collected a sum of Rs. 22,000/- (the seized extorted money) from educational institutions located in valley area.

Hence, he was arrested from the spot i.e., at Takyel Khongbal Khumanthem Leikai near a Bridge at 02:52 pm by observing necessary formalities.

From his possession (i) one iPhone 14 Pro Max mobile handset along with one Vodafone SIM card bearing mobile no. 8794498761 (as disclosed by him), (ii) one iPhone 12 mobile handset along with one Jio SIM card bearing mobile no. 7005950319 (as disclosed by him) and (iii) one brown wallet containing a sum of Rs. 7,120/- (Rupees seven thousand one hundred and twenty only) and one PAN Card bearing no. CQHPA8930N were seized at the spot at 02:59 pm by observing due formalities.

Hence, the arrested persons and the seized articles are handed over to you for taking further necessary legal action against them.
