Subject: Complaint against Shri Yumnam Bhumeswor Singh, S/o Y. Shyamsundar Singh of Langmeidong Mamang Leikai, Kakching District, Manipur for furnishing false/fabricated date of birth.

Sir,

Shri Yumnam Bhumeswor Singh furnish his date of birth as 13/2/1988 along with a copy of the Matriculation Certificate for admission in JNMDA for the course namely, Diploma Course Sankirtana (Pung) 2012-2013 and Post Diploma Course Sankirtana (Pung) 2015-2016.

The aforesaid date of birth i.e. 13/2/1988 was found to be fabricated and false including the matriculation certificate he furnished at the time of admission. The said criminal act was came to the light after getting his actual date of birth from the controller of examination Board of Secondary Education Manipur vide letter dated 22/3/2025. The actual date of birth of Y. Bhumeswor Singh was 13/2/1985.

The said criminal action of Y. Bhumeswor Singh came into light following an RTI application seeking his actual date of birth from the office of the JNMDA. Later on, JNMDA communicated/informed to Shri Yumnam Bhumeswor Singh vide office letter dated 27th Feb, 2025 to furnish his actual date of birth. However, he failed and refused to furnish the required information intentionally. Having no alternative JNMDA approached the Board of Secondary Education Manipur on 28/2/2025 by issuing a letter with a request to furnish actual date of birth of Shri Y. Bhumeswor Singh in the matriculation certificate bearing Roll No. 17811 of the year 2001.

Therefore, I request your goodself to take up appropriate legal action against Shri Yumnam Bhumeswor Singh for furnishing false and fabricated documents and date of birth to the Office of the JNMDA and punish him in accordance with law.
