Subject: - Report.

Sir,

I have the honour to state that today i.e. 14/07/2025 at about 11:30 am, a reliable information was received regarding the presence of some active cadres of KCP(MFL) organization (a faction of KCP organization) in and around Thangal Bazar area with a view to commit prejudicial activities like extortion of money from shops and general public etc. Based on the information, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri. P. Achouba Meitei, MPS, Dy.SP(CDO)IW and under the supervision of Shri. Gaurav Dogra, IPS, i/c Addl. SP(Ops.)IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at Thangal Bazar area. During that two suspected persons were detained at Thangal Bazar near Kasturi Bridge, Imphal West District. On spot verification, the detainees identified themselves as (i) Moirangthem Gandhi Singh (34 yrs.) s/o (L) M. Jarma Singh of Awang Sekmai Bazar, Imphal West District and (ii) Mutum Anand Meitei (37 yrs.) s/o M. Kunjeshor Meitei of Awang Potsangbam Khullen, Potsangbam Khoiru, Imphal West District.

During preliminary verification, they disclosed that they are the active members of KCP(MFL) organization (a faction of KCP organization).

On spot verification, Moirangthem Gandhi Singh disclosed that he joined KCP(Noyon) organization (a faction of KCP organization) in the year 2014 through one Bobby (Finance Section) KCP(Noyon) organization. He further disclosed that he is presently working for KCP(MFL) organization under the command of one s/s Commander Rainson @ Puwangba (Ph. Nos. 8158040549/ 6009659889) of KCP(MFL) organization from Pungdongbam side. Further, he disclosed that under the instruction of his commander Rainson @ Puwangba, he along with his above mentioned associate namely Mutum Anand Meitei was involved in extortion activities by serving monetary demand/threat to shops located in valley area.

Again, Mutum Anand Meitei disclosed that he is presently working for KCP(MFL) organization under the command of the above mentioned Moirangthem Gandhi Singh as his s/s Commander. He further disclosed that under the instruction of his commander Moirangthem Gandhi Singh, he along with him was involved in extortion activities by serving monetary demand/threat to shops located in valley area.

On thorough verification, they disclosed that on 12/07/2025, they served monetary demand/threat to Sanmati Traders Shop located at Thangal Bazar and Moirangthem Gandhi Singh also gave a new mobile number of commander Rainson @ Puwangba (unable to remember the new mobile number as it was deleted from his mobile phone) to the said mobile shop for further communication with commander Rainson @ Puwangba. They also disclosed that today i.e., 14/07/2025, they again served monetary demand/threat to the said mobile shop.

Hence, they were arrested from the spot i.e., at Thangal Bazar near Kasturi Bridge, Imphal West District at 01:02 pm and 01:10 pm respectively by observing necessary formalities.

From the possession of Moirangthem Gandhi Singh, (i) one Redmi Note 8 Pro mobile handset along with one Airtel SIM card bearing mobile no. 8413848067 (as disclosed by him) and (ii) one black wallet containing a sum of Rs. 4,050/- (Rupees four thousand and fifty only) and one Aadhaar card bearing no. 3806 6605 8868 were seized at 01:16 pm by observing due formalities.

And from the possession of Mutum Anand Meitei, (i) one Redmi 10A mobile handset along with one Airtel SIM card bearing mobile no. 8798544110 (as disclosed by him) and (ii) one brown wallet containing one Aadhaar card bearing no. 9416 6495 6949 were seized at 01:18 pm by observing due formalities.

Hence, the arrested persons and the seized articles are handed over to you for taking further necessary legal action against them.


