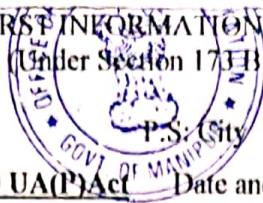

Sir,



I have the honour to state that today i.e. 18/07/2025 at about 06:05 pm, a reliable information was received from our own source and further corroborated from the information input provided by 33 AR regarding the presence of some active cadres of KCP(PWG) organization (a faction of KCP organization) in and around Paona Bazar area under City PS with a view to commit prejudicial activities like extortion of money from shops and general public etc. Based on the information, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri. P. Achouba Meetei, MPS, Dy.SP(CDO)IW and under the supervision of Shri. Gaurav Dogra, IPS, i/c Addl. SP(Ops.)IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at Paona Bazar area. During that one suspected person was detained at the Parking area of Polo Ground, Paona Bazar. On spot verification, the detainee identified himself as Nanaoh (43 yrs.) @ Boboy c/o Kumariliu of Langkhong Village, Noney District.

From his possession (i) one Samsung Galaxy M15 5G mobile handset along with one Airtel SIM card bearing mobile no. 7085166848 (as disclosed by him) and (ii) one brown wallet containing a sum of Rs. 70/- (Rupees seventy only) and one Aadhaar card bearing no. 7180 4345 9756 were recovered.

During preliminary verification, he disclosed that he is an active member of KCP(PWG) organization (a faction of KCP organization) and joined the said organization in the year 2024 and he is presently working under the command of s/s Commander Maiken (Ph. No. 8414811248/7085134429) of KCP(PWG) organization. He further disclosed that under the instruction of Commander Maiken, he was involved in extortion activities by serving monetary demand/threat to shops located in valley area and also involved in illegal settlement of case related to crime against women by means of criminal intimidation in valley area.

On checking his mobile handset, some videos and photos related to extortion activities like demand letter/note, beating/threatening of people, wearing combat dress with arm etc. were also found.

Hence, he was arrested from the spot i.e., at the Parking area of Polo Ground, Paona Bazar at 07:32 pm and the above recovered articles were seized at 07:40 pm by observing necessary formalities.

Hence, the arrested person and the seized articles are handed over to you for taking further necessary legal action against him.
