Sir,

I have the honour to report that today i.e. the 19th July, 2025 at about 2:30 p.m. received a reliable information from our own source about the presence of some anti-social elements at Kangla Pat, Imphal West District. Based on the said information, teams of CDO/IE Unit under the command of Inspt. N. Devdas Singh, OC-CDO/IE Unit rushed to the said area and conducted a searched operation after providing prior information to Imphal-West District Police Control Room at about 3: 30 p.m.

In that, one suspicious unknown person was detained for spot verification and checking at Kangla Pat near GM Hall, Imphal-West District. On checking the body of the detainee, one mobile phone and one wallet were found and recovered. On verification, the detainee identified himself as one Prem Yumnam @ Thawai @Ibungo (23 years) S/o Y. Shamo Singh of Langmeidong Lai Manai Naya Bazar, Waikhong PS, Kakching District. On further verification, the detainee stated that, he is an active member of the outfit UPPK, joined through one Mr. Henen of UPPK in the month of April, 2024 and got his basic military training for 45 days under the command of one s/s 2nd Lieutenant Mr. Phidam of UPPK. The detainee further stated that he is presently working under the command of one s/s-Army Chief Mr. Ingeljaio of UPPK.

So, the detainee was arrested from the spot i.e. Kangla Pat Near GM hall, Imphal West 3:56 p.m. by observing due formalities. From the possession of the arrestee; (i) One mobile phone (Galaxy A12) bearing IMEI no. 352724162567928/01 & 353110212567929/01 along with two SIM cards bearing no. Jio 8787444630 & Airtel-6909778545 and (ii) one wallet containing a sum of Rs. 130/- (one hundred thirty rupees) and one AADHAR card were seized at the spot i. e. i.e. Kangla Pat Near GM hall, Imphal West 4:00 p.m. by observing due formalities.

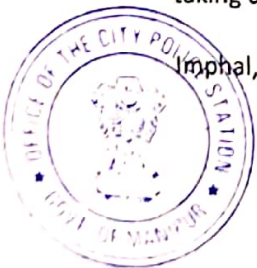
Therefore, the arrested person along with the seized items is being handed over to you for taking up further necessary legal actions against him.
