I the undersigned have the honour to state that today i.e. 29/07/2025 at around 9:55 am, I along with my police party were on patrolling duty in and around Thangal Bazar area Imphal and while reaching near the Hon'ble Speaker (Manipur Legislative Assembly) quarter, Major Khul, opposite to Manipur press club an unknown person seems to be a user was seen with some pieces of aluminium bar.
