Sir,

I have the honour to report that today ie 10/07/2025 at around 10.10 pm, received a reliable information that some unknown persons were transporting stolen vehicles from Sangaiyumpham area to other place where they had already contacted with their associates. Acting on the information, I along with police team of Thoubal-PS rushed at Wangbal to Samaram IVR near Fishery Farm Office and conducted frisking & checking. In a far distance a Scooty was seen coming towards the frisking point from Sangaiyumpham side. As it gets closer, suddenly the unknown individual stopped the vehicle and fled away towards paddy field taking advantage of darkness thereby abandoning the scooty.
