

Subject Report.


Sir,

I have the honour to report that on 25/7/2025 at about 1:40 am, in pursuance of a requisition submitted by NCB, Guwahati regarding police assistance for a raid at the house of Md. Abdul Matalip Khan @ Ithem, 46 yrs S/o Md. Nurumuddin Khan of Sangaiyumpham Mairenkun Mayai Leikai in connection with FIR case no. 10/2025 of NCB, Guwahati, organised a combined team led by Shri N. Suraj Singh, Addl.SP(LO)/TBL comprising OC-Thoubal PS, self, 4(teams) of CDO-TBL including teams of NCB Imphal and conducted a raid at the house of Md. Abdul Matalip Khan @ Ithem, 46 yrs S/o Md. Nurumuddin Khan of Sangaiyumpham Mairenkun Mayai Leikai.

During the house raid, one suspect was detained and on verification, the individual identified himself as Md. Abdul Matalip Khan @ Ithem, 46 yrs S/o late Md. Nurumuddin Khan of Sangaiyumpham Mairenkun Mayai Leikai. As the said individual was involved in the above FIR case, the police team were preparing necessary formalities for his arrest. In the meantime, the family members of the individual started raising alarm and developed a hostile situation in order to restrain police from discharging lawful duties. Within a few moments, Md. Abdul Matalip Khan @ Ithem along with some neighbours including his family members started violent attacks towards the police team thereby obstructed police activities. The family members of Md. Abdul Matalip Khan who led the violent attack were (1) Md. Jamir @ Tenden aged about 26 yrs s/o late Md. Nurumuddin Khan and (2) Mrs. Kurba Sahani 21 yrs w/o Md. Jamir (3) Mrs. Talabi w/o Md. Abdul Matalip Khan @ Ithem and (4) Md. Kamaruddin Khan @ Kamal aged about 54 yrs s/o late Md. Nurjaman. During the said violent attack, Md. Abdul Matalip Khan @ Ithem managed to escape from the scene taking the hostile situation. One constable driver Manglemba Singh, driver of Addl. SP(L/O) TBL was injured and two Maruti Gypsy vehicles (1) bearing regn. No. MN01W-1559 allotted to G-35 CDO/TBL and (2) bearing regn. No. MN1K-9790 allotted to Addl. SP(L/O) TBL were also damaged in the said attack. In order to evacuate the injured police driver in the midst of violent attack, a total of 5 (five) rounds of 9mm Pistol were fired in the safe direction by Addl. SP(L/O) TBL after giving due warning to disperse the mob.

It is therefore, requested to take up necessary legal action in this regard.
