Today i.e. 4/8/2025 at 10:25 am, received an information that on the same day at about 10:15 am, a road traffic accident occurred at Khangabok along NH102 in front of District Hospital, Thoubal Main gate in between three vehicles i.e. (1) TATA DI bearing regn. no. AS01DC4150 (1) HONDA ACTIVA bearing regn. no. MN01C9105 and (3) SUZUKI A STAR bearing regn. no. MN06LX6152 due to rash or negligent driving on the part of the TATA DI driver. As a result, the unknown male rider of HONDA ACTIVA bearing regn. no. MN01C9105 and its one unknown female pillion rider sustained severe injuries and evacuated to the District Hospital, Thoubal. However, the said female pillion rider succumbed to injury at District Hospital, Thoubal. The above mentioned three vehicles were also damaged. Hence the case.
