While dismantling the structures at encroached land, on the same day at about 1 pm, around 10 individuals led by (1) Md. Mustakim aged about 28 yrs s/o Md. Acique Ali of Sangaiyumpham Part II Cherapur Saalam Makok (2) Md. Yunush Khan aged about 27 yrs s/o MV Ahamad Ali of Sangaiyumpham Part II Cherapur Mayai Leikai (3) Md. Jakir Khan aged about 35 yrs s/o late Md. Tombi of Sangaiyumpham Part II Cherapur Mathak Leikai and (4) Md. Niraba aged about 25 yrs s/o Md.
