Today i.e. 10/08/2025 at 9:25 pm, received information that on the same day at around 9:18 pm, one Himalayan bike B/reg. no. MN01AL-7775 proceeding from Thoubal towards Wangjing side collided with a Diesel Auto B/reg. No. MN01Y-1903 while the diesel auto was crossing the NH 102 from the western side to eastern side for entering into the Wangbal Charangpat IVR at near Congress Office, Wangbal along NH 102 due to rash or negligent driving/riding on the part of the both vehicles. As a result, the rider and two pillion riders of the Himalayan bike, the driver and five occupants of the diesel auto sustained injuries and were evacuated to District Hospital, Thoubal for medical treatment. Both the vehicles were also partly damaged.


