Today i.e. 13/08/2025 at 2:05 pm, received information that on the same day at around 1:30 pm. gradually the general public of the nearby area began to gather while conducting search operation by District Police, Thoubal comprising of Commando Unit Thoubal led by Shri Y. Sunanta, MPS, Dy. SP (HQ), Thoubal and Inspector K. Nitaranjan Singh, OC/CDO Unit Thoubal assisted by HC W. Premananda Singh, HC M. Raghumani Singh, Hav. Md. Abdul Karim and Hav. L. Rameshchandra Sharma to detect contraband Heroin/Brown Sugar which may have kept concealed at the house of Sangomsungbam Nasir Khan (29) yrs S/o Sangomsungbam Ahamed Ali located at Khekman Amakcham. Accordingly, the police team detained Sangomsungbam Nasir Khan (29) yrs S/o Sangomsungbam Ahamed Ali of Khekman Amakcham and detected some contraband substances from the said house. Thereafter, as the CDO team began to detect the contraband items, the public formed an unruly mob. In the meantime, some of the persons among the mob started banging the electric poles to alarm the local people. The unruly mob was being at to form by the family members of the said detainee with the assistance of their neighbour by way of pelting stones also trying to assault the police team by holding/using articles of different description which may be used as offensive weapons in order to prevent/disturb the legal procedure of the incident. As a result, the police team swiftly left from the place along with the detainee and recovered items.
