Sir,

I have the honour to report that today i.e. 16/08/2025 at about 11:40 a.m. while I was on conducting frisking and checking duty at District Hospital Main Gate opposite, one Honda Pleasure+ grey in colour was coming from Thoubal side towards Khangabok side in a very suspicious manner. Due to his suspicious nature, the Honda Pleasure+ was stopped and detained the rider for verification.

On preliminary verification, he identified himself as Md. Nawas Khan (31) yrs. s/o. late Mohd. Naha Khan of Tentha Makha Leikai Sangaiyumpham Mairenhun, Thoubal District. On his body search found (i) 1 (one) Aadhaar card bearing No. 8970 3786 2033 and (ii) 1 (one) OPPO A5s mobile handset along with Airtel SIM card bearing mobile number 8296970644 from his possession. On further checking the Honda Pleasure+ bearing registration No. MN01A L8555 is suspected to be stolen vehicle one. On further verification he disclosed that he and his associate Md. Nasir Khan s/o. Md. Maida Ali @ Driver of Sangaiyumpham Puleipokpi had lifted the said Honda Pleasure+ bearing registration No. MN01A L8555 from Athokpam Khunou. Hence, he was arrested at 11:50 a.m. of 16/08/2025 from District Hospital Main Gate opposite and seized the above mentioned (i) 1(one) Honda Pleasure+ bearing registration No. MN01A L8555, (ii) 1 (one) Aadhaar card bearing No. 8970 3786 2033 and 1(one) OPPO A5s mobile handset along with Airtel SIM card bearing mobile number 8296970644 from his possession at 11:52 a.m. of the same day by observing formalities.

The arrested person mentioned above along with the seized articles is handed over to you for taking further legal action against him.
