Nashimuddin of Moijing Heirak Leikai was physically assaulted by the following persons namely Md. Atabur Rahaman aged about 42yrs S/o late MV. Nashimuddin of Moijing Heirak Leikai and Md. Haji Agha aged about 47yrs S/o late MV. Nasimuddin of Moijing Heirak Leikai by holding weapon like club (cheitup) without any reason at Moijing Heirak Leikai near the Jame Masjid gate while my husband was came out from the said Masjid. As a result of it, my husband got injury and evacuated to District Hospital Thoubal for medical treatment. Further, he was referred to higher hospital for treatment to his injury.
