Received a report from ASI Paotinkai Haokip of G.SPM PS that based on specific input received regarding drugs being transported, a joint team of Kangpokpi District Police led by Shri SL Kamkhohao, MPS, ASP(DHQ)-KPI, Inspt. Thangpu Kipgen, OC/G.SPM PS, Self -A.S.I Paotinkai Haokip, one team of G/232 Mahila CRPF led by AC Aishwarya Joy, D/88 BSF, G/94 CRPF led by Inspt. Jagdish Singh along with WPCs of G.SPM PS, Unit QAT 112 Bn CRPF U/c ASI Mukesh Tomar under the supervision of AC TST Baite and under the over all supervision of SP-KPI conducted frisking and checking of vehicle at Kholep junction along NH-2 today i.e. 01-08-2025 at 4:30 pm. While Checking of one passenger auto bearing No. MN01AB-9625 carrying passengers, one woman among others on being in a suspicious manner was asked to get down from the said auto who later identified herself as Lhingneichong @ Hechong Hangshing(42) W/O Lalminthang Hangshing of Kangpokpi ward No. 9, PO & PS: Kangpokpi, Kangpokpi District, Manipur. She was given option U/S 50 NDPS Act for body search in which she agreed and later found to be in possession of contraband drugs and in the meantime Executive Magistrate-Shri T.Khaiminlal Haokip has been informed of the matter and the Executive Magistrate also arrived at the spot. On body search of the said woman, she was found in possession of - (1) Suspected brown sugar in a transparent plastic weighing about 252 grams including the weight of the plastic, (2) Rs 22,000/- (Rupees twenty two thousand only) and (3) One Vivo Smart phone Y 28e 5G along with one Airtel SIM - 8798303014. The individual has been arrested at the spot on the same day at 5:30 pm and the contraband suspected brown sugar have been seized at 5:40 pm in presence of witnesses by observing formalities. On preliminary interrogation, she stated that the contraband item is to be delivered to one Rebicca and Kusum. As such Police teams are put on high alert and mobilised, accordingly, a joint team led by S.I Mangjalam Kipgen, OC/MTB-OP along with WPC, one team of F/94 CRPF led by AC Prasant Kumar Jena, one team of G/232 Mahila CRPF, one team of B/94 CRPF led by AC Ashok Kumar in presence of Executive Magistrate conducted house search of the residence of one Rebicca Haokip at Gangiphai. On house search, the following contraband items have been recovered from the residence of One Rebicca Haokip and seized at the spot in presence of witnesses by observing formalities on the same day at 6: 10 pm viz-

At the instance of the arrestee Lhingneichong @ Hechong Hangshing, house search was conducted at her residence at Kangpokpi ward No. 9 by a joint team led by ASP(DHQ)-KPI, team of KPI PS, team of GSPM PS led by WSI Chongpi Doungel, One platoon of B/112 Bn CRPF led by Inspt GD Mukadal Ali, QAT of Dett 94 CRPF attached with SP-KPI in presence of Executive Magistrate Lunlenmoi Vaiphei at 6:50 pm and recovered the following items viz-

1. Suspected brown sugar weighing about 2.20 kgs containing in a black plastic including the weight of the plastic
2. 3(three) packets of T. Amul Tea Special containing suspected opium wrapped together in one black plastic weighing 2.835 Kgs including weight of the plastic
3. One black polythene containing suspected Ganja weighing 140 gms including weight of the plastic and the same have been seized at 7:00 pm in presence of witnesses by observing formalities. The two arrested persons along with the seized items have been handed over to you for further necessary legal action. Hence a case under FIR No. 20(8)2025 G.SPM PS U/S 21(c)/18(b)/20(b)(1)(ii)(A) ND & PS Act has been registered for investigation.

I have the honour to state that based on specific input received regarding drugs being transported, a joint team of Kangpokpi District Police led by Shri SL Kamkhohao, MPS, ASP(DHQ)-KPI, Inspt. Thangpu Kipgen, OC/G.SPM PS, Self -A.S.I Paotinkai Haokip, one team of G/232 Mahila CRPF led by AC Aishwarya Joy, D/88 BSF, G/94 CRPF led by Inspt. Jagdish Singh along with WPCs of G.SPM PS, Unit QAT 112 Bn CRPF U/c ASI Mukesh Tomar under the supervision of AC TST Baite and under the over all supervision of SP-KPI conducted frisking and checking of vehicle at Kholep junction along NH-2 today i.e. 01-08-2025 at 4:30 pm.
