With due regards, I beg to state that today on 14/08/2025 at about 11:00 a.m. received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at foothill of Phouoibi village for using offensive act against State Security Forces and CAPF.

On receipt of the information, Thoubal District Police along with 4 AR COB, Thoubal Tomching and a column of A-Coy 91 Bn. BSF led by OC/NSK-PS have rushed to the spot immediately and launched a massive operation at 11:30 a.m. On searching and found the undernoted articles i.e. (i) 2(two) nos. local made single barrel (ii) 5(five) nos. of 7.62 mm live rounds (SLR) (iii) 5(five) nos. of 5.56mm live rounds (iv) 5(five) nos. of 7.62 mm Fcc ammunitions (empty) (v) 3(three) nos. of 9mm Fcc Ammunitions (empty) (vi) 1(one) no. of Baofeng set (vii) 1(one) no. of SRL mag. and (viii) 1(one) no. of 9mm mag. from the spot and seized at 11:50 am. The massive searched Operation was conducted from 11:30 am to 12:10 noon on the same day.
