Directorate of Science & Technology, Old Lambulane, Imphal,
Manipur.

Sir,

With all due respect I am to report that I am a ret'd. Joint Director of Dept. of Science & Technology, Manipur (retired on 28/02/2025). On 25/07/2025 at around 4.00 pm, I visited the said office for taking some documents such as Income Tax, return filing form No. 16, pension papers, GIS sanction orders etc. but when I just arrived at the office and sitting in the room of Shri Lenthoi Marim Chothe, UDC. In the meantime, 2 (two) staff of the department namely Shri Kh. Jitkumar Singh (Accountant) and Md. Abdul Hasim (Peon) came very angrily with intention to assault me with life attempt throwing the iron chairs and helmet towards me and further they physically assaulted me on different parts of my body. Moreover, they pushed me on the ground and repeatedly assaulted me. As a result of the assault, I sustained injuries on my body and was admitted to Urban Primary Health Centre (UPHC), Singjamei, Imphal.

In this regard, I am to say that I could not report to the Imphal Police Station on the same day due to my injuries and having high blood pressure.

In this connection, it is therefore requested to kindly take appropriate legal action against them as per law at an early date.




