Sir,

With due respect, I have the honour to state the following few lines for your kind perusal and further necessary action.

That, on 19/05/2025 individual namely Rehan Kuraishi (35 yrs) S/o Aslam Kuraishi of 632, Kotana, Baghpat Kotana, Uttar Pradesh A/P Tangel Hotel, Thangal Bazar reported with OC/Imphal PS stating that he is a Proprietor of Anni Overseas Ext. Ltd., based at Reaction Depot, Upper Khalini, Shimla, Himachal Pradesh. On 30<sup>th</sup> April 2025, he entered into a business agreement with two individuals, one Banu Devi (60) and one Homeshor (40). As per their agreement, he was to supply three truckloads of watermelons from Bihar to Imphal. Accordingly, he dispatched two truckloads on 2<sup>nd</sup> May and 3<sup>rd</sup> May 2025. However, upon reaching Nagamapal Lai Esing Chaibi, Imphal West District, Manipur, both Banu and Homeshor unexpectedly refused to honor the agreement or accept the consignment. At this juncture, he was approached by Mrs. Jaysharee Nameirakpam (50) and her husband Mr. Shyam Nameirakpam (50) of Kongba, near Standard College, Imphal East District, Manipur. Having known them for over a year and trusting their assurances, he allowed them to take possession of the two truckloads of watermelons from Nagamapal Lai Esing Chaibi on 5<sup>th</sup> May, 2025 with the promise that they would assist in selling the product. The third truckload was redirected to Bechiman, Assam and sold there, following their instructions. Unfortunately, after the sale of all three consignments, Jaysharee Nameirakpam (50) and Shyam Nameirakpam have failed to pay him the agreed-upon amount. He has made multiple attempts to contact them via phone (Jaysharee: 9402257703; Shyam: 9402756575), but their calls have gone unanswered. Furthermore, when he visited their residence to resolve the issue, Mr. Shyam issued threats of serious consequences instead of offering any resolution. This situation has caused him considerable financial loss and emotional distress. Thus, they have cheated him and looted him. Hence the case and conducted an enquiry.

During the course of the enquiry, it was found that the complainant namely Rehan Kuraishi (35 yrs) S/o Aslam Kuraishi of 632, Kotana, Baghpat Kotana, Uttar Pradesh A/P Tangel Hotel, Thangal Bazar was cheated by the alleged accused persons Jaysharee Nameirakpam (50) and her husband Shyam Nameirakpam (50) of Kongba, near Standard College, Imphal East District, Manipur. They took the possession of the two truckloads of watermelons with the promise that they would pay after selling. But they refuse to pay despite repeated request by the complainant. As such the alleged accused persons Jaysharee Nameirakpam (50) and her husband Shyam Nameirakpam (50) cheated the complainant with dishonest intention thereby misappropriated the property of the complainant.



It is therefore, requested your good self to kindly take up a regular FIR and book the culprits according to the law of the land at the earliest.
