

We have been operating a Secondary School at Uripok for the past ten years, committed to serving the community through quality education. During this period, various groups-including certain student unions-have repeatedly tried to coerce us for financial contributions or admission favors. We have consistently resisted such demands.

Two months ago, we formally lodged a complaint with your office (Dated 28/4/2025), and we are grateful for the prompt assistance extended at that time.

However, over the past two to three months, one Prepak Tomba (mobile: 9233239817) has been visiting our campus, demanding money ostensibly to purchase arms and ammunition. He always wears a mask and helmet, and on 19 July 2025, he came again to issue fresh threats. He has also sent intimidating text messages to our Administrative Officer.

In light of these persistent and alarming extortion attempts, we humbly request that you:

- 1. Register our renewed complaint and initiate a thorough investigation into Prepak Tomba's activities.
- Provide protective measures for our staff, students, and premises.
- 3. We also request you to instruct existing police post in our school to be more vigilant and
