Sub: Report of attempt of cheating by using forged documents.

Sir,

I am directed to report an incident of cheating and forgery by one Md. Hussain Ahamed, Vety. Attendant (EIN-092307) while giving Sureties for accused persons released on bail by the Special Judge (NIA), Imphal West. He stood as sureties in several occasions by giving false information viz. (1) Ayekpam Chingkhui Meitei of Lamshang Lamdeng Khunou, Imphal West in c/w FIR Case No. 37(7)2024 Nambol P.S. U/S 17/20 UA (P) A. Act., (2) Yumnam Lanchenba @ Naoba of Lalambung Takhellambam Leikai, Imphal in c/w FIR No. 498(09)2024, Imphal P.S. U/S 17/20 UA (P) Act & 25 (1-B) Arms Act, (3) Laishram Langamba Meitei of Moreh Ward No. 1, A/P Akampat Relief Camp in c/w FIR No. 48(12)2024 of Lamshang P.S. U/S 221/223 BNS, 25(1-A) Arms Act, 5 Explosives Subs. Act & 10/12 UA (P) Act and (4) Huidrom Kishan Meitei of Kanto Sabal Awang Leikai in c/w FIR No. 104(8) 2024 City P.S. U/S 17/20 UA (P) Act.

In due course, the documents he submitted became doubtful to whether the signature purported to be that the Joint Director (DDO) of District Vety. & A.H. Services Office, Thoubal are genuine or not and the Director of Veterinary & Animal Husbandry, Manipur was requested for conducting verification in this regard vide this Office letter of even No. dated 12th March, 2025. The Director vide his letter dated 27th May, 2025 forwarded a verification report submitted by the former Joint Director, District Veterinary Office, Thoubal. In the report it is confirmed that Md. Hussain Ahamed is serving as a regular Vety. Attendant, however some of the signatures purported to be that of the DDO are not genuine.

In the above premises, it is revealed that Md. Hussain Ahamed has attempted to cheat the Court by using forged documents and as such it is requested to kindly register an FIR against him and investigate into the matter for the ends of justice.
