One complainant namely Shri Ngangom Uttam Singh, Director Social Welfare, Manipur submitted a complaint report to Superintendent of Police Imphal East stating that on 27th June, 2024 the Directorate of Social Welfare came to know about the existence of "Letter of Acceptance" address to one Anjel Limited, Located at 106, Link Plaza Commercial Complex, New Link rd, Oshiwaram Jogeshwar(W) Mumbai-400102 regarding procurement of e-learning product for a total cost of Rs.197,60,97,500.00 (Rupees One hundred ninety seven corers sixty lakhs ninety seven thousand five hundred) supposedly issued by the Department of Social Welfare in relation to supply of E-Learning product as pilot Project of NIPUN BHARAT.

At the very onset, it is highlighted that as far as the project Bharat is concerned, education department is the nodal department and as such, there is no necessity for this department to issue such a letter, and, the signature appearing in the aforesaid letter purported to be of the undersigned, was forged. No tender has been floated by this department for procurement of such equipment's till date

Additionally, as per our official records, the file No/ letter No. mentioned in the letter as reference also does not exist. And there is no official record of having any kind of correspondence with Anjel Limited for any project, whatsoever.
