Today i.e. 10/08/2025 at 05.30 pm, received an information that on the same day at about 05.20 am, a road traffic accident occurred at Mao Market, along NH 102, Imphal West District, Manipur involving one Hero Destini 125, Blue in colour, bearing Regn. No. MN01AL-6890 and one Royal Enfield GT 650 without Regn. No. due to rash and negligent driving on the part of both the drivers. As a result, both the drivers sustained serious injuries and was immediately evacuated to Raj Medicity Hospital for medical treatment.

Hence, a suo-motu case under FIR No. 276(8)2025 IPS u/s 281/125(b)/324(4)BNS has been registered against the drivers of both the involved vehicles for investigation.
