Subject : Report.

Sir,

With due regards, I beg to state that today on 15/07/2025 at about 4:30 a.m. received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at the foothill of Tentha Tuwaband for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with a column of 33 Assam Rifle, a column of 2 MAHAR Regiment and one section of 10 BSF led by Shri Y. Sunanta, MPS, Dy.SP(HQ), Thoubal and Inspt. K. Nitaranjan Singh, OC/CDO-TBL under the supervision of Shri. H. Devendra Singh, Addl. SP(Ops)/TBL and under the overall supervision of Shri Shivanand Surve, Superintendent of Police, Thoubal rushed to the spot immediately and launched a massive operation at 5:00 a.m. On searching the undernoted articles i.e.

were found from the spot at 5:30 a.m. Hence the above noted articles were seized at 6:14 a.m. by observing formalities. The massive searched operation was conducted from 5:00 a.m. to 5:50 a.m. on the same day.

It may be mentioned that all the necessary formalities under BNSS i.e. preparation of seizure memo and arrest memo by taking videography during seizure could not be done at the spot as information was received from intelligence sources that some members of the above said unlawful organisation may attack or some organised public mob may be initiated to forcefully free the arrested accused person.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
