Today, i.e. 02/08/2025 at 2.35 pm, received a reliable information that on the same day at around 02:33 pm one Tata Ace Gold light goods vehicle, Cream in colour bearing registration No. MN06T- 2278 plying from Kakching side towards Wangjing side driven by an unknown driver dashed on the back side of one Honda Pleasure, white in colour bearing registration No. MN06SC-9461 plying through same direction in the front of Khongjom PS Gate, along NH No. 102, due to rash or negligent driving on the part of the Tata Ace Gold light goods vehicle. As a result of which the unknown rider of Honda Pleasure and the 2 (two) pillion riders sustained injuries on their persons and evacuated to District Hospital Thoubal for medical treatment and the Honda Pleasure, White in colour bearing registration no. MN06SC- 9461 was partly damaged.
