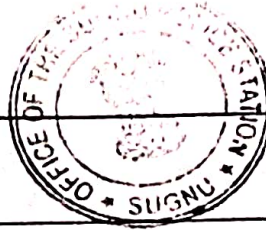

Brojen @ Thomba of the said banned organization. **Further disclosed that he was actively involved in monetary extortion activities in Kakching District and Thoubal District areas. He was also tasked to collect illegal taxes from Schools and Brick Fields owners operating in Kakching and Thoubal District.** From his possession, 2(two) mobile handsets i.e (1) OPPO A5 Mobile handset bearing IMEI Nos. (a) 869625043506918 and (b) 869625043506900 along with 1 (one) Airtel SIM No. 8732840572 and (2) Redmi Note 9 Pro Mobile handset bearing IMEI Nos. (a) 860846059384771 and (b) 86084059384789 along with 1 (one) Airtel SIM No. 8730021769 were seized at the spot at 09:13 pm and videography of the same was done at the spot.
