In that, one suspicious unknown person was detained for spot verification at Elang Khangpokpi Awang Leikai, Maning Pat, Kakching District. On checking body, one mobile phone was found and recovered from his possession. On verification, the detainee identified himself as one Lourembam Suresh @ Mairongba @ Toto (47 years) S/o L. Tomba Singh of Heirangoithong Oinam Leikai, Imphal West. On further verification, the detainee sated that he joined the outfit through one Mr. Dhanabir of KCP (PWG) group in the month of May, 2023 and presently working under the command of one s/s – Camp Commander Mr. Kiran of KCP (PWG) group.
