I, Naorem Brojen Singh, aged 68 years S/o (L) Naorem Ghāneshwor Singh old, resident of Kakching Wairi Khunyai Leikai, Khongnang Lamteiba Pareng, am writing this application to report a serious case of **domestic violence and attempt to take my life by my son, Naorem Aakarson Singh (30) years**

Over the past several months, I have been repeatedly subjected to **physical assault, verbal abuse, and threats** by him. Despite my efforts to resolve the situation peacefully, the abuse has continued and has escalated dangerously.

Today 23-07-2025 at about 9:45 am, he attempted to **physically harm me and my brother with the intent to kill** with deathly weapons (Knife, Sharp Spades, Log etc) at my resident. This kind of events has been happening from the past several months/years.

Here is the list of main events that happened with the dates:

1. On 21/07/2025, During night he ran out of the house suddenly from the bed and threatened to kill someone with log in his hand.
2. On 15/07/2025, he threatened his own mother with the knife in his hand for not giving money (This type of events happens almost everyday).
3. On 2/07/2025, he threatened to kill me with sharp spades after mild arguments about losing and buying a new mobile phone.
4. He roams around with knife in his hand attempting of killing someone in my area. Due to this, people are getting scared whenever they saw him.
5. All the neighbouring family are locking their doors almost all the time because of his violent behaviors (thievery, fearness, social disturbance etc)
6. On around March month, he had an unnecessary argument with his elder brother namely Dixon Singh which leads him and got injured severely (scars can be seen on his brother's face till date).

In the evening, when my son-in-law namely Ksh. Sachin Singh visits my home, he intentionally tried to kill my son in law with a sharp knife for a small consoling advice.

These are only few of the mentioned events that had happened. His violently/deathly nature has been observed from the past 3/4 years.

Over the last 18 years, we had put him into the rehabilitation center across all the rehabilitation centers existed in Manipur but there is no worthy or gain at all.
