I have the honour to report that today i.e 27/07/2025 at @ 5.30 PM my elder brother's son namely Md. Anash Khan (23) yrs was called out by one Md Amar (30) yrs S/o Md. Khamba of Sora Ching Wangma through his phone for some conversation. Unfortunately, he was already waited at Sora Awang Leikai by 4 persons namely (1) Md Amar (30) yrs S/o Md. Khamba of Sora Ching Wangma (2) Md. Akbar (24) yrs S/o Md. Khamba of Sora Ching Wangma (3) Md. Haship (20) yrs S/o Md. Khamba of Sora Ching Wangma & (4) Md Khamba (60) yrs of Sora Ching Wangma in one Bolero White in Colour B/Regd. No. MN01AW 7412. And as soon as they saw him the four persons came out from the vehicle and started attacking him by dangerous weapons i.e Long Knife, Baseball Bat, Hockey Stick. And in the meantime his father also came to stop them from fighting. But, he was also attacked by them. As a result of which they both received serious injury and evacuated to Jivan Hospital Kakching for medical treatment. But, they were refer to Raj Medicity Imphal. Some 5(Five) other persons who were stopping the fight were also got injured during the incident and treated at Jivan Hospital Kakching.

So, I therefore requested you to kindly take up necessary legal action against them according to law.
