Sir,

I have the honour to report that today i.e 27/07/2025 at @ 5.30 PM my younger brother's son namely Md Amar (30) yrs along with his Brother-in law went to his wife house in one Bolero Car. Before reaching his wife's house they stop the vehicle and went to a shop for eating Pan "Kwa" own by one Nahaibem located at Sora Mayai Leikai. But unfortunately Md Amar was stopped by Nahaibem and called some persons i.e (1) Md Iboyai (40) yrs S/o Md. Meralaudrei of Sora Mayai Leikai (2) Md. Anash (28) yrs S/o Md. Iboyai of Sora Mayai Leikai (3) Md. Jiten (40) of Sora Mayai Leikai (4) Tamu (40) yrs W/o Md. Iboyai of Sora Mayai Leikai and started assaulting him including herself i.e Nahaibem (35) yrs W/o Md. Jiten of Sora Mayai Leikai by using dangerous weapons like Knife, Iron rod at the gate of her house located at Sora Mayai Leikai. In the meantime Md Amar's two younger brothers namely (1) Md Akbar (27) yrs S/o Md. Khamba of Sora Chingwangma (2) Md. Ashik (20) yrs S/o Md Khamba of Sora Chingwangma also came to help his brother but they both were also assaulted by them. As a result of which three of them were received serious injuries and evacuated at Thoubal Hospital for medical treatment

So, I therefore requested you to kindly take up necessary legal action against them according to law.
