With reference to the complainant report filed by one Hijam Sangita Devi (32) yrs D/o H. Niren Singh of Naoremthong Samushang Uku, Imphal West Dist. to the Officer -in-Charge, Kakching PS, I have conducted and enquired into the matter with due permission from SDPO-KCG dated 08/08/2025 U/S 137(3) of BNS.

During the course of enquiry, the complainant was examined very carefully and recorded her detail statement in c/w the enquiry and found that the alleged person is the husband of the complainant. The alleged person has the habit of drinking alcohol and getting violent thereby torturing the complainant in several occasions. In-spite of stopping his violent activity towards the complainant, an incident again occurred on 15th of Oct. 2023 where the alleged person has attempted to kill the complainant by assaulting her very hard at her husband residence located at Kakehing Paji Leikai, Ayangbung Pareng, Kakehing District. As such she was evacuated to RIMS Hospital by some neighbors for her medical treatment. Following her discharge from the hospital, she went to I/W, Women Police Station, Lamphel and lodged a complaint report. But she was told to proceed at Kakching PS as the matter was to be taken up at Kakching PS. Unfortunately, the complainant hasn't turn up to the said police station (Kakching PS) as she was scared coming at Kakching.

In the course of further enquiry, examined some PWs and also the medical reports submitted by the complainant and on examination a prima facie case is well made out against the alleged person for assaulting and threatening her and also attempt to murder and needed to register a regular FIR case so that the investigation can be done delve deeper.

So, I am submitting my enquiry report to you for taking further necessary action please.
