
It is to report that today i.e. on 02/05/2025 at around 0930 hrs. received a reliable information regarding presence of unknown miscreants at Thongam Khunou area who are involved in extortion activated on receiving the input, teams of CDO Unit Kakching cordoned off and search was conducted in the suspected area at Thongam Khunou area. During the search one suspected individual matching with input received was detained at Thongam Khunou, Kakching Khunou Ward No. 1 along the Moirangkhom-Kakching Khunou IVR.

On preliminary examination, the detainee identified himself as Khumukcham Gopen Singh @ Tamthiba (37) yrs S/o. (L) Kh. Akhom Singh of Thongam Khunou Kakching Khunou Ward No. 1, Kakching District, On questioning, he disclosed that he is an active cadre of the banned organization Socialist Revolution Party of Kangleipak (SOREPA), a faction of KYKL. He joined the banned organization SOREPA (a faction of KYKL) in January 2025 through one S/S Army Chief Kh. Samu @ Luwang of the said banned organization and working under his command. Further, he disclosed that he was actively involved in monetary extortion activities in Kakching district area. He was also tasked to collect illegal taxes from businessman and saw mill owners operating in Kakching District. From his possession, one mobile Redmi Note 8 bearing IMEI 1-868269043198706 and IMEI2-868269043198714 along with Jio sim No.9366641718 was seized at the spot at 1050hrs and videography of the same was done.

Following the admissions, the said individual was arrested from the spot at 1053 hrs. by observing formalities.

The arrested individual along with the seized item and arrest Memo are handed over to you for taking further necessary action.
