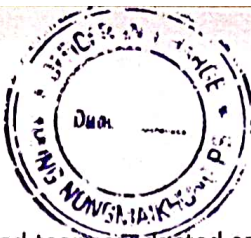

Subject: Report

Sir,

I have the honour to report that on 18/07/2025 at around 4:50 AM, a reliable input was received from own source about the presence of some arms and ammunition of banned organization PREPAK being concealed at Chingjao area under Arong Nongmaikhong PS, Kakching District.

Acting on the input, a combined teams of CDO-BPR and CDO-KCG led by Sub. S. Birla Singh, OC/CDO-KCG and Inspt. Y. Motilal Singh, OC/CDO- BPR assisted by Jem. Shanti Singh of CDO-BPR, SI. A. Rajkumar Singh of BPR PS, ASI. Kh. Prameshwor Singh of CDO-BPR, Hav. Samuel Kamei of CDO-BPR, Hav. Kh. Kunje Singh of CDO-BPR, HC. K. Bidyashwor Singh of CDO-BPR, HC. L. Kunjakeshwor Singh of CDO-KCG, HC. K. Starson Tarao of CDO-KCG and Hav. N. Chaoba Singh of CDO-KCG along with a team of Arong Nongmaikhong PS, conducted cordon and search operation at the said area under the supervision of Shri Amarjit Singh Lamabam, MPS, Addl. SP(Ops) Bishnupur under the overall guidance of Shri Ksh. Ravikumar Singh, IPS, Superintendent of Police, Bishnupur District and Smt. L. Priyadarshini Devi, MPS, SP Kakching immediately rushed to the said area and conducted an extensive search operation by cordoning the suspected Chingjao area to prevent any unwanted activities.



During the course of operation, the combined team conducted search by digging up at suspected areas. While digging up at a location on the eastern side of the Chingjao island, the joint team succeeded in recovering the undernoted incriminating ammunitions at Chingjao island, Pumlem Pat which was wrapped in a plastic sack and buried at the site.

- 1) 1406 (One thousand four hundred and six) nos. of 9 mm ammunitions.
- 2) 125 (One hundred twenty five) nos. of .303 ammunitions.
- 3) 7 (Seven) nos. of blank cartridge.
- 4) 1 (One) no. of Plastic sack used in concealing the incriminating articles.

The above noted recovered items were formally seized from the spot at 09:32 am along with videography of the seizure procedure.

Now, therefore the seized items along with the seizure memo are handed over to you for taking further necessary action.




