Subject: Report.

Sir

I have the honour to report that today i.e. 26 /07/2025 at about 4:30 am received a reliable information about hiding of weapon cache by unknown miscreants in general area Lairok Ching. Based on the reliable input shared by 2 Mahar Regiment and confirmed by own sources, Five teams of CDO, Kakching unit led by Subedar E. Subhachandra Singh, under the command of Subedar S. Birla Singh along with one column of 2 Mahar Regiment led by Major Aditya Jain and one team of Arong Nongmaikhong PS led by ASI Yakub Ali along with myself have conducted search operation at Lairok Ching from 05:11 hrs to 05:40 hrs under the overall supervision of Smt L. Priyadarshini, MPS, SP/Kakching. During the search operation, 3 (three) rice bags suspected to be kept concealed by unknown miscreants were recovered from a secluded bushy area of Lairok Ching.

While opening the said bags, the following arms and ammunition along with other materials were found.

- 1) 1 (One) 7.62 SLR Body No. CC3512 with 1.(one) empty Mag.
- 2) 5 (five) Nos. of Single barrel bearing body No. (i) FC 8953, (ii) ATL-73, (iii) MS-107, (iv) AZ-9134 and (v) AZ (Modified)
- 3) 1 (One) .303 rifle bearing body No. 06209 with 1 (one) empty magazine
- 4) 1 (One) .32 pistol bearing body No. UX4378 (Modified) with 1 (one) empty magazine
- 5) 6 (Six) nos. of IED.
- 6) 2 (two) Baofeng wireless handset with 5 chargers.
- 7) 20 (twenty) nos. of .303 live round ammunitions
- 8) 15 (fifteen) nos. of empty case of AK 47 ammunition.
- 9) 10 (ten) nos. of empty case of 7.62 SLR ammunition.
- 10) 3 (three) empty rice bags.

As such the above noted warlike inventories have been seized from the spot at 05:18 am by observing formalities and recorded a video graph of the action of recovery.

The seized items along with the Seizure Memo are handed over to you for taking further action by registering an FIR.
