At around 10:05 pm, one suspected vehicle (similar to the vehicle in question) came towards the Naka point from Wabagai bazar side and it was also observed that it was being chased by one CDO team of Kakching. Our police team signaled and tried to stop the suspected vehicle but it did not stop and sped away. Our team also hurriedly followed the vehicle from behind along with the CDO team but it disappeared in some area before reaching the Sekmaijin outpost. Later more CDO teams joined in searching the said vehicle but it could not be detected.

As search went on received a reliable information, at about 12:10 am of 22/4/2025 that the said suspected vehicle was seen to have gone towards Khoidum village IVR. Accordingly, I along with my mobile team, rushed to Khoidum area and conducted search in the areas.
