Today i.e. 31/05/2025 at 10:00 pm, ASI. Md. Sakir Ahmed of Cammando Imphal East Unit lodged a written report to OC/HLM-PS stating that from the last few days, the combined team of Imphal East Dist. Police and 21 PARA (SF) were working on a reliable input of an unlawful organization, KCP-PWG, led by SS Maj M. Amitab @ Khaba that his team is extorting large sum of money from the General Public and the Government Officials and also involved in kidnapping. It is also learned that the said group is also involved in looting arms and ammunition of the Government Armories. Further, the combined team launched an Operation within the Districts of Imphal East, Thoubal and Kakching under the supervision of the SP/IE. In that, yesterday i.e. the 30th May, 2025, at about 10:00 a.m. we received credible information from Inspector Md. Rajib Khan, In-Charge Cyber Crime Unit IE and 21 PARA(SF), about a cache of large nos. of arms and ammunition at Wabagai Thingel Leikai, Hiyanglam PS, Kakching District. The information was corroborated by a combined covert surveillance team and minutely filtered by Inspt. Md. Rajib Khan, In-Charge Cyber Crime Unit IE. Based on the said information, a combined team of CDO/IE Unit comprising ASI. Abdul Khalill of CDO/IE Unit, Hav. No. 05006254 Th. Gyanizial Singh of 1st MR/CDO/IE and 21 PARA (SF), HC Maxwell Th. of Cyber Crime Unit IE under the command Shri. Y. Joyraj Singh, MPS, Addl. SP(Ops)IE rushed to the said area after providing prior information to Kakching District Police and launched a search operation at Wabagai Thingel Leikai, Hiyanglam PS, Kakching District at 12:05 p.m.

In that, on searching the residential compound, an area of thick bamboo plantation (*Wapan*), of one Mayengbam Sobha of Wabagai Thingel Leikai, Hiyanglam PS, Kakching District, following arms and ammunition were recovered at 12:30 p.m. of 30th May, 2025 :-
