I have the honour to state that, today i.e. 17/04/2025 at about 5.00 a.m., based on a reliable information, a search operation was conducted at Wabagai Buffalo farm areas under Kakching Police Station from 5.30 a.m. to 7.20 am by a combined team comprising of CDO unit Kakching led by Sub. S. Birla Singh OC/CDO Unit, Kakching and a team of KCG Police Station led by ASI. L. Surjit Singh, one platoon of 'F' Coy 67 Bn. BSF Adhoc M & C XIV, under the supervision of Binoy Chongtham, MPS, Addl. SP(Ops), Kakching and under the overall supervision of Smt. Priyadarshini Laishram, MPS, Superintendent of Police Kakching District, Manipur. During the search operation the area was cordoned off and search was conducted at suspected areas. On searching at a secluded area near bushes, the
