Based on the said information, a combined team of Imphal West District Police Commandos and one column of 33 AR, under the command of Shri Gaurav Dogra, IPS, Addl SP (Ops) IW and OC CDO IW and under the overall supervision of Shri Ksh. Shivakanta Singh, IPS, SP Imphal West, rushed to the said area after providing prior information to the concerned District Police and conducted CI Ops at @ 6:20 pm at the said area. In that, one suspected person was detained for sport verification and checking at Wabagai Bazar near Doren Meat Hotel, Kakching District. He identified himself as Elangbam Jogen Singh @ Sanathoi, aged about 39 yrs S/o E. Kumar Singh of Hiyanglam Mayai Leikai, PS Hiyanglam, Kakching District, Manipur. He disclosed himself as a cadre of KCP (PWG) working under one Saphaba of KCP(PWG). Recently, he is involved in intimidating Pardhan and Ward Members of Wahengkhuman and Sanjenbam-Pukrambam Gram Pachayats by calling them at Sekmaijin area of Kakching District (at the residence of his elder sister) on 20th & 21st April, 2025 and snatching away of 13 (thirteen) mobile phones belonging to the Pradhans and Ward members and demanded Rs. 50,000/- (rupees fifty thousand only) each from Ward Members and Rs. 5 (five) lakhs and 10 (ten) lakhs from Pradhans of Wahengkhuman and Sanjenbam-Pukrambam Gram Pachayats respectively. He was arrested at 6:45 PM by observing necessary formalities.
