I have the honour to state that, today i.e. 16/05/2025 at about 3.45 a.m., based on a reliable information from 2 Mahar Regiment corroborated with 31AR, a search operation was conducted at Kharungpet area near Buffalo farm under Kakching Police Station from 4.30 a.m. to 6.00 a.m. by a combined team comprising of CDO unit Kakching under the command of Sub. S. Birla Singh OC/CDO Kakching, one column of 2 Mahar Regiment led by Maj. Aditya Jahn and one column of 31AR led by Maj. C. Su Vioek, under the overall supervision of Smt. Priyadarshini Lalthlun, MPPS, Superintendent of Police Kakching. During the search operation the area was cordoned off and search was conducted at suspected
