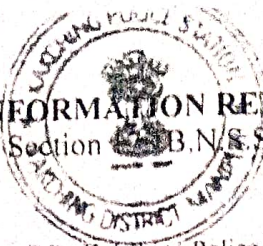

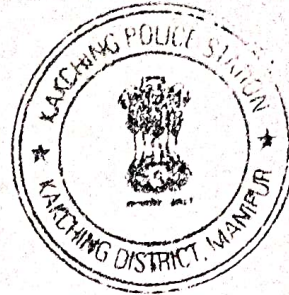

I have the honour to report that today i.e. 21/05/2025 at around 1430 hrs. based on a reliable information about the presence of some members of banned organization SOREPA at Kakching areas, a combined team of CDO Kakching and a column of COB Waikhong, 46 AR led by Maj Mahesh rushed to the said area and established a mobile check point at Kakching-Tejpur crossing along IVR, Road, near MSPDCL Power Sub-Station. During the course of frisking and checking two unknown individuals matching with the input was seen coming by foot from Tejpur towards Kakching MSPDCL Power Sub-Station. The two individuals were detained at the spot. On questioning, they were identified as (i) Khumukcham Amuthoi Meitei 45 yrs S/o Kh. Indramani Meitei of Kakching khunou Umathel Awang Leikai, Kakching District (ii) Mayanglambam Premchand Meitei 41yrs S/o. M. Rajen Meitei of Kakching khunou Umathel Makha Leikai, Kakching District.

On further verification, they admitted that they were active cadres of the banned organisation SOREPA (a faction of KYKL). Khumukcham Amuthoi Meitei 45 yrs revealed that he joined in July 2024 through one Khumukcham Samu @ Luwang of the banned organisation. And Mayanglambam Premchand Meitei 41yrs revealed that he also joined SOREPA in July 2024 through one Khumukcham Samu @ Luwang of the banned organisation.

Following the admissions both were arrested one after another from the spot at 1530 hrs and 1535 hrs by observing formalities. From the production of Khumukcham Amuthoi Meitei 45 yrs recovered one Keypad Mobile handset CELLECOR (black in colour) bearing IMEI1- 350201089588925 & IMEI2- 350201089588933 along with Airtel SIM No.8414822924 and from Mayanglambam Premchand Meitei 41yrs recovered one Redmi 5G mobile (grey in colour) bearing IMEI1-863199064686583 & IMEI2- 863199064686591 along with Airtel SIM No. 7630814340. The same were seized from the spot one after another by observing formalities at 1540 hrs and 1545 hrs and videography of the same was done at spot.

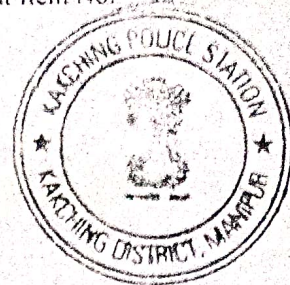
