On reaching at Wabagai Makha Leikai Heibong Makhong Crossing conducted frisking and checking by established a mobile check point. During the course of frisking and checking our team notice one unknown person which was coming by foot from Wabagai Keithel Macha towards the check point in a very suspicious nature. Due to his suspicious nature the said individual was detained for verification. On basic questioning, the individual was found restless and did not provide satisfactory response. As his nature became suspicious, he was taken to CDO office, Kakching for further examination and verification at the spot was not possible as there was security apprehension for the frisking team and due to darkness of spot. On examination, the detainee identified as one Maibam Virendrakumar Singh@ Saphaba(32) yrs. S/o. (L) M. Rajen Singh of Wabagai Yangbi Maning, Kakching District. Further he disclosed that he is an active member of banned outfit organization KCP (Taibanganba) and joined the banned outfit organization in the month of April, 2024 through one Coporal Sunil Sharma of the said banned organization. Further on questioning, he disclosed that he was involved in extortion money from general public at Thoubal and Kakching District areas.

Following the admissions, the said individual was arrested from the office of the CDO-Unit Kakching at 1715 hrs. From his possession one Redmi 8A Mobile Phone bearing IMEI1- 869956041238752 & IMEI2-869956041238760 along with Airtel Sim bearing No. 6909782369 were formally seized at the office of CDO Unit, Kakching at 1725hrs and videography of the same and documentation was also done at CDO office, Kakching.






