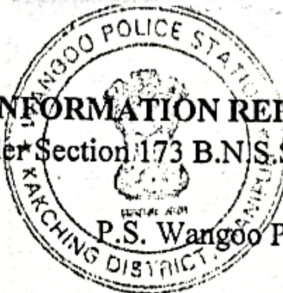

On receiving the input, teams of CDO Unit Kakching and a column of 46th AR led by Major Mahesh OC Pangantabi F-Coy cordoned off and search was conducted in the suspected area at Wangoo Chairrel Sabam area. During the search one suspected individual matching with input received was detained at Wangoo Chairrel Sabam area, Kakching District.

On preliminary examination, the detainee identified as Sarangthem Premananda Singh @ Nanao (35) yrsS/o. S. Amu Singh of Kakching khunou Tampak yum lai Leikai, Kakching District. On questioning, he disclosed that he is an active cadre of the banned organization PREPAK-PRO. He joined the banned organization PREPAK-PRO in May 2024 through one Dhananjay @ Prem (from Khordak) of the said banned organization and working under the command of sergeant Major Damen @ Meitei. Further he disclosed that he has been actively involved in monetary extortion activities in Kakching district area. He has been also tasked to collect illegal taxes from business establishment in Kakching District. He further stated that earlier he joined the banned organization PREPAK

In 2002 and got 45 days basic training at Khoupum, Tamenglong and he was arrested in 2007.

From his possession, one key pad handset blue in colour bearing IMEI 351830192327828 along with Jio sim No.7005529609 was seized at the spot at 1102 hrs. and videography of the same was done.

Following the admissions, the said individual was arrested from the spot at 1105hrs. by observing formalities.

The arrested individual along with the seized item and arrest Memo are handed over to you for taking further necessary action.


