I have the honour to report that today i.e. 02/06/2025 at about 4.00 am, based on a reliable information from 2 MAHAR REGT., a search operation was conducted at Wangoo Naral Samtak Hill areas under Wangoo Police Station from 5.30 am to 8.10 am by a combined team comprising of CDO Unit Kakching led by Sub. Rakib Khan, a column of 2 MAHAR REGIMENT led by Major Aditya Jain, under the overall Supervision of Smt. Priyadarshini Laishram MPS, Superintendent of Police Kakching. 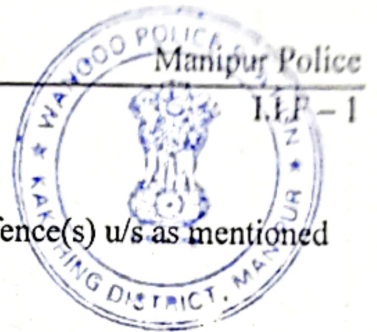


