Sir,

I have the honour to state that today, i.e., 30/07/2025 at 11:30 am, I went to my paddy field located at Keirampalli Komjao Loukol. I parked my Activa 6G, Decent Blue Metallic in colour having regd no. MN06SF5906, Chassis no. ME4JF91ABNW054808, Engine No. JF91EW7054862 which stands in the name of Mohammad Azmir Khan S/o Ataur Rahaman of PYA Club Kairang Mayai Leikai, Litan Makhong under proper locked and key beside the roadside of Keirampalli IVR. While I was working at the paddy field, I notice two suspicious persons near my vehicle, and then they took away my vehicle driving. I along with the peoples present at the paddy field shouted and chase them. Luckily, we apprehend one of them along with my lifted vehicle near Keirao Litan Makhong at 1:00 pm. However the other person managed to escape.

The apprehended vehicle lifter identified himself as Mohmed Zarish Ahmed aged about 18 yrs S/o Md. Abdul Hakim of Lilong Haoreibi Awang Leikai. On questioning, he revealed that he came with his partner namely Md. Tajul (aged about 18 yrs) S/o unknown of Lilong Dam.

The following are the items found from the Md. Mohmad Zarish Ahmed S/o Md. Abdul Hakim of Lilong:-

- (i) My Honda Activa 6G, Decent Blue Metallic colour having regd no. MN06SF5906
- (ii) Two numbers of T-Shape metal tools,
- (iii) One Master-key of 6G Activa vehicle (as identified by the thief)
- (iv) One mobile phone, Redmi Note 11T, blue in colour having 2 (two Airtel sim cards bearing phone no. (i) 8131922929 and (ii) 7628060709. (as disclosed by the thief)

I request you to kindly take up legal action against Md. Mohmad Zarish Ahmed under appropriate sections of law. I am ready to co-operate fully with the investigation and provide my statement or testimony as required.

Kindly acknowledge this complaint and register an FIR.
