Subject: Report

Respected Sir,

I have the honour to report that today i.e 03/06/2025 while I was staying at our Khongnang Pheisabi Police Outpost along with other Police/VDF/MR personnel some firing sounds were heard towards the eastern side sentry Post of our Police Outpost at about 1:30 pm. Accordingly, I along with police team immediately proceeded toward the firing side in order to verified and confirm the reason of firing from the personnel detailed for sentry duty. In that, we came to know that the firing was committed by Rfn. No.082010223 of 8<sup>th</sup> MR namely Kabrabam Ibomcha Singh (36) yrs S/o (L) K. Sanaton Singh of Serou Bazar Awang Leikai, PO&PS- Sugnu, Kakching District, Manipur who was detailed for sentry duty at eastern side sentry post. I along with Hav. No.9138 Md. Nijamuddin of 8<sup>th</sup> MR and other personnel called his name and told him to stop firing from a safe distance location. However, he continued to fire even including towards our direction. So, we were unable to reach near his location.

However, after a few moments the firing was stopped and some of our police/ VDF and MR personnel immediately rushed near the eastern side Santry post and saw that Rifleman Kabrabam Ibomcha Singh was lying at his place of duty. When we reached near him we found that Rfn. No.082010223 of 8<sup>th</sup> MR namely Kabrabam Ibomcha Singh (36) yrs S/o (L) K. Sanaton Singh of Serou Bazar Awang Leikai, PO&PS- Sugnu, Kakching District, Manipur was lying as dead body at his place of duty with bleeding injuries on his person. It was suspected that he must have committed suicide by inflicted injuries to himself by using his service weapon.


