Complainant namely Head Constable Maxwell Thokchom, Cyber Unit/IE lodged a written report to OC/APS at 06:28 pm stating that on the same day at about 11:00 a.m. a reliable input of an unlawful organization, KCP-PWG, led by SS Maj M. Amitab @ Khaba that his team is extorting large sum of money from the General Public, the Government Officials and also involved in kidnapping (.). It is also learned that the said group is also involved in looting arms and ammunition of the Government Armories (.). Further, the combined team is carrying out Counter insurgency Operation within the Districts of Imphal East, Thoubal and Kakching under the guidance of the Shri. Rakesh Balwal, IPS Sr. SP/IE, under the supervision of Shri. Y. Joyraj Singh, MPS, Addl. SP (Ops) IE and under the command of N Devdas Singh OC-CDO/IE (.). In that, from Inspector Md. Rajib Khan, In-Charge Cyber Crime Unit/IE today i.e. the 4th June, 2025, at about 11:00 am provided credible information about the above mention out lawful organization cache large numbers of arms and ammunitions at an area of Yairipok Changamdabi Chingya, Imphal-East District, and Manipur. Based on the said information, a combined team of CDO/IE Unit, 21 PARA (SF) and a team Cyber Crime Unit IE led by HC H. Dolenjit Singh and Maxwell Thokchom for launched an operation (.). In that, on searching the hide-out areas of Yairipok Changamdabi Chingya to the said KCP-PWG, SS Maj M. Amitab @ Khaba following arms and ammunition were recovered at 04:28 pm of 4th June, 2025 i.e. 1) 1(one) no. of 5.56 INSAS rifle marked as '18244875' with magazine, 2) 1(one) no. of Lathod Gun marked as '10473' 3) 10(ten) nos. of .303 live ammunition, 4) 6(six) nos. of 7.62 live Ammunition, and 5) 6(six) nos. of 5.56 live Ammunition (.). After the recoveries and formally seizure of the above mentioned arms and ammunitions the combine team carried out search operation in different hide-out places which the said SS Maj M. Amitab @ Khaba took shelter (.). Thereafter, all the suspected looted arms and ammunitions of the government armories, which were recovered during the operation, are being handed over to you for taking up further necessary legal procedures. Hence, the case.
